W08-71859-V(A) IN THE CRIMINAL DISTRICT COURT NUMBER THREE FROM DALLAS COUNTY Per Curiam. O R D E R This is an application for a writ of habeas corpus which was transmitted to this Court by the clerk of the trial court pursuant to the provisions of Article 11.07, Section 3, of the Texas Code of Criminal Procedure. Ex Parte Young, 418 S.W.2d 824, 826 (Tex. Crim. App. 1967). Applicant was convicted of theft and punishment was assessed at two years' confinement. After a review of the record, we find that the fact issues raised in this application were not resolved, and the writ should be granted. See Ex parte Young, 418 S.W.2d at 826. Therefore, we remand this application to the Criminal District Court No. 3 of Dallas County so that the trial judge may make findings of fact as to whether a tape or CD recording was made, and if so, what the capacity of the tape or CD recording is and whether such tape or CD recording contains all evidence relating to her conviction. The trial court may take any other action it deems appropriate in light of its findings. The trial court shall appoint counsel to represent Applicant on remand. The trial court shall certify whether or not it is required to give Applicant credit for time spent released on bond on the offense for which she was convicted. The trial court shall make findings of fact as to whether the Applicant's sentence is being served consecutively or concurrently and whether or not Applicant is eligible for release on bail. The trial court shall also make any other findings of fact and conclusions of law that it deems relevant and appropriate to the disposition of Applicant's claim for habeas corpus relief. This application will be held in abeyance until the trial court
